## 1. INTRODUCTION

The Justice, Crime Prevention and Security Cluster (JCPS) is entrusted to implement the Government's Delivery Agreement (Outcome 3) aimed at ensuring that "All People Are and Feel Safe". The Government has committed through the Delivery Agreement to reaffirm its international and constitutional obligations to take positive action to promote, protect, respect and fulfill the rights of women and children.

Women of all ages experience inequalities within and outside their homes. Moreover, they suffer from the burdens imposed by gender-based hierarchies, subordination, abuse and violence which restrict them from enjoying their human rights. The violent nature of crime affects everyone but especially vulnerable groups such as women, children, older persons and people with disabilities.

The Western Cape Development Committee (WC Devcom) is the implementing structure of the Justice, Crime Prevention and Security Cluster within the Region and it promotes the development of policies and strategies, which strengthens the criminal justice system.

The WC Devcom has resolved to coordinate a uniform programme within the Western Cape to ensure the promotion of gender equality, the protection of women's rights and the promotion of efficient, effective and speedy justice services to vulnerable women and children. A key strategy of the Women's month programme is the development of a conceptual framework, which aims to ensure that the JCPS cluster collaboratively work together in promoting gender equality within the Western Cape.

This **Women's Month 2014 Concept** sets out a comprehensive outreach strategy and campaign in line with Government's Women's Month Theme "**CELEBRATING 60 YEARS OF THE WOMEN'S CHARTER AND 20 YEARS OF FREEDOM: MOVING WOMEN'S AGENDA FORWARD!**" and it responds to the challenges facing women. The programme activities aim to educate communities and to highlight government's key legislation, policies and strategies relating to women and gender during Women's Month.

## 2. **BACKGROUND**

The Government of the Republic of South Africa declared August month as Women's month and 9 **August** is celebrated annually as Women's day in commemoration of the thousands of women who marched to the Union Building on **9 August 1956** in protest against the extension of pass laws to women and to celebrate the achievements of women.

August month also serves to remind the people of South Africa that the struggle for women's freedom, justice and equality continues in South Africa. Women's oppression and the dominance of patriarchal structures, whether within the family or in the community, is sustained largely because of their lack of access to services and resources. There is a danger that women's human rights may slide into irrelevance unless women understand their rights and Government provides an enabling environment for women to access services, which promotes and protects these rights and ensures the advancement of women within the home, community and society at large.

Women's month is particularly important to the JCPS Cluster as it allows the departments and stakeholders of the JCPS Cluster to engage with communities and to intensify public education and awareness on women's rights.

The Delivery Agreement is based upon an overall outcome, which is linked to a set of selected outputs. The JCPS cluster has identified 7 (seven) key output areas and each of the outputs in turn is linked to the activities required for the objectives of the specific output to be achieved i.e.

Output 1: Reducing overall levels of serious crime, in particular, contact and trio crimes

Output 2: A more effective criminal justice system

Output 3: Reducing corruption and promoting investor and community confidence

Output 4: Managed and improved perceptions of crime among the population

Output 5: South Africa borders effectively safeguarded and secured

Output 6: Integrity of identity and status of citizens and residents secured

Output 7: Secure cyber space

The activities of the Women's Month programme is a focused intervention, which aims to impact on the perception of crime within the communities, promote its services, which protects women and children and fulfil its international and constitutional obligation to stop all forms of discrimination against women and children.

#### 4. **OBJECTIVES OF THE PROGRAMME**

The objectives of Women's Month are:

- To advocate for women's rights, promotion of gender equality and the protection of women and children through education and outreach activities within communities;
- To reduce gender based violence through awareness campaigns and informing communities of their responsibilities to promote gender equality and end violence against women and children; and
- To capacitate the JCPS cluster departments and partners in promoting women's rights through collaborative training and learning and the development of shared strategies and policies to promote gender equality and the reduction of violent crimes against women.

## 5. **OUTCOMES**

The outcomes of the Women's Month programme are:

- To uphold Government's commitment in respect of Outcome 3 of the Delivery Agreement, its international and constitutional obligations, the National Development Plan and Government's gender strategy to protect and promote women's rights in collaboration with communities and civil society organisations;
- Communities collaboratively working together and taking ownership for women's issues and the protection of women and impacting on the perception of crime and reduction of crime; and
- Access to governments services, effective service delivery and eradication of corruption within the JCPS cluster.

## 6. **TARGET GROUPS**

Women and children with a specific focus on the following groups:

- Vulnerable women and children with a special focus on persons living with disabilities;
- Survivors of sexual violence;
- Pregnant teenagers and the girl child at school;
- Families, communities and civil societies in rural and disadvantaged areas within urban areas;
- Farmworkers and Farm dwellers;
- Women-Headed households;
- Women and girls in correctional facilities and Child and Youth Care Centres; and
- Refugees and unaccompanied minors.

## 7. **TARGET AREAS**

The JCPS Cluster's Women's Month programme will focus its activities within the following areas:

- Areas where there are a high prevalence of sexual violence, rape, domestic violence, substance abuse, teenage pregnancies and violence in schools. The areas will be identified collaboratively with SAPS; and
- Disadvantaged communities, schools, partial care facilities, farms, correctional facilities and CYCC's in rural areas.

#### 8. **PROGRAMMES OF WOMEN MONTH**

The Western Cape Development Committee's events planned for Women's Month will take place for the period **1 August 2014 until 31 August 2014**. These events will focus on addressing the concerns of identified communities in respect of the criminal justice system, access to justice and frontline services.

The events will take place in the form of:

**Programme 1: JCPS Service Delivery Imbizos** which will inform targeted communities of rms of the criminal justice system.

**Programme 2: Community Outreach Programmes** which will be held in partnership with the various JCPS Cluster departments and civil society organisations.

**Programme 3: Access to Justice Week** aims to inculcate a culture of community service within the legal fraternity through the provision of free legal advice at identified Advice Offices / Community Based Organisations.

- 8.1 **Programme 1: JCPS Service delivery imbizos and launch of Women’s Month** will inform targeted communities of their rights in terms of the criminal justice system, with a particular focus on maintenance and domestic violence, sexual offences matters, and will be used as an opportunity to evaluate whether the criminal justice services are satisfactory. It is proposed that the JCSPS Cluster Departments host 8 service delivery imbizo’s.

**10.1.4 Annual public service women management week**

Each JCPS cluster department have been encouraged to host a Women’s Month programme for female staff within the JCPS cluster promoting the 8 (eight) Head of Department’s ( HOD’s) principle Plan of Action for promoting Women’s empowerment and gender equality within the Public Service Workplace.

The eight (8) principles are:

- Transformation for non-sexism;
- Establishing a policy environment;
- Meeting equity targets;
- Creating an enabling environment;
- Gender mainstreaming;
- Empowerment;



- Providing adequate resources; and
- Accountability, monitoring and evaluation.

9. **Programme 2: Community Outreach Programmes**

The Community Outreach Programme will be held in partnership with the various JCPS cluster departments and civil society organisations. The purpose of the outreach programme is to create awareness on women and gender issues and interventions by the different government departments promoting and protecting women's rights. The activities will take the form of information stalls and blitzes, Master's Services; SAPS search operations, SAPS Forensic Workshops, Tracing Operations, Community Dialogues, Awareness, and Marches.
