- 4) I am aware that while the funds are so invested with the said Bank, the funds are not protected against a possible Liquidation of the said Bank.
- 5) I further warrant that all relevant legislation pertaining this agreement has been complied with and shall continue to be complied with.
- 6) I hereby confirm that the instructions given by myself herein constitutes a valid agreement between myself and the Sheriff
- 7) I have read, understand and agree to be bound by the provisions of this agreement upon signing this form.
